A) The production of inyection moulding process to produce rigid poly(vinyl chloride) unplastized (PVC-U) fittings, components and parts for piping and drainage systems (soil and waste, pressure and gutter).

The production of inyection moulding process to produce unplastized rigid poly(vinyl chloride) (PVC-U) and polypropilen (PP) fittings for soil waste discharge.

The production of fiberglass reinforced polypropylene mechanical joints between fittings and polyolefin pressure pipes for invection moulding process.

The sale of polypropylene fittings for evacuation wastewater of sanitary equipments.

B) The production of unplasticized poly(vinyl chloride) (PVC-U) and oriented PVC (PVC-O) pipes for water under pressure, the production of unplasticized poly(vinyl chloride) (PVC-U) for sewerage pipe non pressure underground and the production of PVC-U pipes for soil rainwater and water discharge.

C) The production of PVC-U double walled corrugated pipes for sewerage drainage and electric installation.

The production of PVC-U pipes for evacuation of rain water and wastewater and the production of PVC-U gutters and down comers for rainwater collection.
